

## Camden Local Committee – Helpful Information

ClubGRANTS funding scheme is for projects and/or services that contribute to the welfare and broader social fabric of the local community, and are aimed at improving the living standards of low income and disadvantaged people. \* ClubGRANTS Guidelines—Gaming Machine Tax Act 2001—August 2021.

- The Local Committee round will open on the 1st of February and closes on the 31st of May 2025
- Please review the application process (how to apply) and the eligibility criteria before submitting an application <https://www.clubgrants.com.au/how-to-apply>
- Projects and/or services must be delivered within, or benefit residents of, the Local ClubGRANTS Committee LGA.
- Projects and/or services must align with one of the categories listed in the 'ClubGRANTS Purpose' list to be considered by the Local ClubGRANTS Committee (see page 2).
- Priority will be given to projects and/or services that align with the Department of Communities and Justice local priorities (see below).
- Funded projects exceeding \$7,500 will require additional documentation and a contract, which will be initiated by the funding club.
- If you have an "open" grant that has not been acquitted from a previous round, you will not be eligible for consideration in the current round.
- All applicants will be contacted via email to confirm the application outcome. If your application is successful, payment will be made prior to the 31st of August.
- If successful, you will be required to send a representative to the Local Committee Presentation, typically held in late July or early August.
